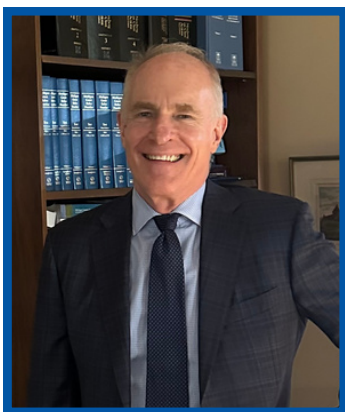




JONATHAN R. MOOTHART
